Dear Cancer Research UK Complaints team

I was alerted yesterday to Cancer Research UK's article on 5G and Wifi 'cancer myth.'

I and other members of the public raised concerns about this article and provided constructive comments yesterday. Sadly, only two comments raising concerns about the Cancer Research UK report on 5G and wifi 'cancer myth' are allowed. CRUK are even censoring the public from rating comments by removing 'thumbs up and down' that go against Cancer Research UK's opinion. I am unable to place a rating on the comments and other people are also complaining about this form of censorship.

Yesterday, Robert F. Kennedy Jr., raised concerns about censorship and Big Tech's collusion with out-of-control government agencies to silence speech at a U.S. House hearing organized by Subcommittee on the Weaponization of the Federal Government.. There are growing concerns with regards to conflicts of interest, censorship of speech and debate with Big Tech collusion. I hope that CRUK can remain independent as representatives of the public rather than big industry.

Here is a copy of my comment sent to Cancer Research UK on 20th July 2023.

Comment: In 2011 the WHO and IARC classified non ionising radiation as a class 2b carcinogen. The same classification as DDT and lead in petrol. Members of IARC with collective judgment found scientific consensus in reaching this decision. The vote was nearly unanimous: 29 to 1. The evidence of increased cancer risks has since been strengthened by further human studies, as well as toxicology studies in animals, which demonstrated clear evidence of tumours. The US govt paid \$30 million to the NTP. The Italian Ramazzini Institute ten-year research project also found clear evidence of malignant tumours. Two different institutes with laboratories in different countries, totally independent of each other and both producing parallel consistent findings, reinforces the validity of these ground-breaking animal studies. Risks associated with this type of radiation are not limited to cancer. Here are some of the most reported symptoms:

- Headaches
- Insomnia
- Fatigue
- Tinnitus
- Heart arrhythmia/palpitations
- Decreased immune function
- Irritability
- Decreased cognitive function

The law also needs to be considered with regards to wireless technology.

Here are two important recent UK legal developments regarding Electrosensitivity -:

The case, EAM v East Sussex County Council (Special educational needs) features a child who suffers electrosensitivity. Upper Tribunal Judge Jacobs found that the child should be considered disabled under the Equality Act 2010, and she required an Education, Health, and Care Plan (EHCP).

June 2022, a 59-year-old UK social worker won 'early ill health retirement' for disabling 'Electromagnetic Hypersensitivity (EHS): In relation to EHS.

I call on CRUK complaints team to accept the comment I provided yesterday and make it available along with other comments to allow important debate on this serious issue.
