#### Dear

I am writing to you to oppose the new WHO Pandemic treaty and the amendments to the International Health Regulations (article 13A, article 42, article 12, annex2) which will remove our rights to democracy, remove our rights to informed consent on what goes into our bodies, and sanctions censorship as well as surveillance of our social communications, thereby removing all privacy and freedom of the people in 194 member states.

All the amendments remove the word 'non-binding' which means that when member states sign the new WHO Pandemic treaty and the latest version of the IHR behind closed doors, the member states effectively lose their sovereignty and thereby throw away the rights and freedoms of their people, without their knowledge.

The people of this world have not been asked or informed that such international health regulations or the WHO pandemic treaty is being signed on their behalf by their governments. The new IHR according to WHO article 21, will effectively be <u>automatically enacted</u> after May 2025, once signed. Informed consent exists on both the individual level and for all democracies. Self determination of the people is one of the founding principles of article 1 of the UN charter, 1946, and this is being violated by this government.

His reasons are as follows: the WHO Pandemic Treaty and the new IHR, as legal instruments, will, with regard to "Pandemic prevention, preparedness and response":

- 1. Diminish our rights to self- determination
- 2. Diminish our right to human dignity
- 3. Eliminate the basic principle of democratic participation
- 4. Force member states to lose their autonomy
- 5. Allow the WHO to have an absolute and non-questionable leadership in all health matters
- 6. Allow the WHO to auto or self declare an public health emergency of international concern and extend it for as long at it pleases
- 7. Allow the WHO to declare recommendations made by certain experts

- 8. Allow the WHO to impose all kinds of restrictions, access restrictions, lockdowns, surveillance of the people and member states and experimental treatments (IHR article 18 contains the list of measures)
- 9. Allow the WHO to <u>impose a proof of vaccination</u> in IHR article 18, which was until now meant to be non-binding
- 10. Allow the WHO to reserve or assume the right to define and to control all information that it claims to be related to health
- 11. Allow the WHO to assume the right to censorship and the right to interfere in social communication
- 12. Not allow the people or member states to challenge the assessment of the WHO with respect to a declaration of a public emergency, or to challenge the imposition of certain legally binding measures, or to challenge the imposition of a regime of vaccinations regardless of how experimental such vaccines might be
- 13. Allow the WHO to have a total monopoly of health information including the right to censorship
- 14. Remove any mechanism of control or correction of the WHO
- 15. Remove all empirical science and proper scientific process because open debate and questioning will be banned
- 16. Remove the decision making process from all people in these member states
- 17. Remove democracy as we know it
- 18. Remove all legal court proceedings or justice as the result is already pre-defined by the WHO
- 19. Remove all power and human rights from the people of each member state as there will be no checks or balancing of the declarations of the WHO
- 20. Allow the WHO to state under what legal basis we live

I am writing to you to say that these new international health regulations proposed are totally against our constitutional order as there will be no public information rights, there will be censorship and human rights will no longer be protected.

I do not want cell and gene-based therapies imposed on me by the nation state. Informed consent will totally go out the window if the WHO Pandemic treaty and the new IHR is signed by the UK government. The new WHO Pandemic treaty in article 3 no longer has the statement, "the implementation of these regulations shall be with full respect for the dignity, human rights and fundamental freedoms of persons," - why would any government sign such a treaty that removes the full respect for the dignity, human rights and fundamental freedoms of persons?

By signing these legal instruments, you will be forcing experimental vaccines onto your constituents. This is a form of terror for many people. Please vote against this form of oppression for the sake of our freedom of choice and our right to live in peace.
